The Share Register is open to any individual who is a member of a Trade Union, Labour or Co-operative Organisation.

And any Trade Union affiliated to the TUC, Co-operative / Labour Organisation or Political Party.

Being an individual shareholder enables that person to participate in the running of Wortley Hall, by attending the Annual Meeting, Shareholders Quarterly Meetings, voting for the officers and standing for office, plus discounts on certain services.

All officers must be individual shareholders.

Shares are in units of £10.00. The minimum issue is 1 share (£10.00) and the maximum 20 shares (£200.00). Shares do not increase in value but remain at face value.

There is no upper limit for Organisations.

Each shareholding organisation is allowed one delegate to the Annual Meeting irrespective of the number of shares held.

Applications are considered by the Management Board for approval on the first Wednesday of each month.
